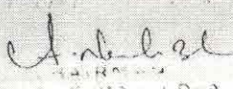

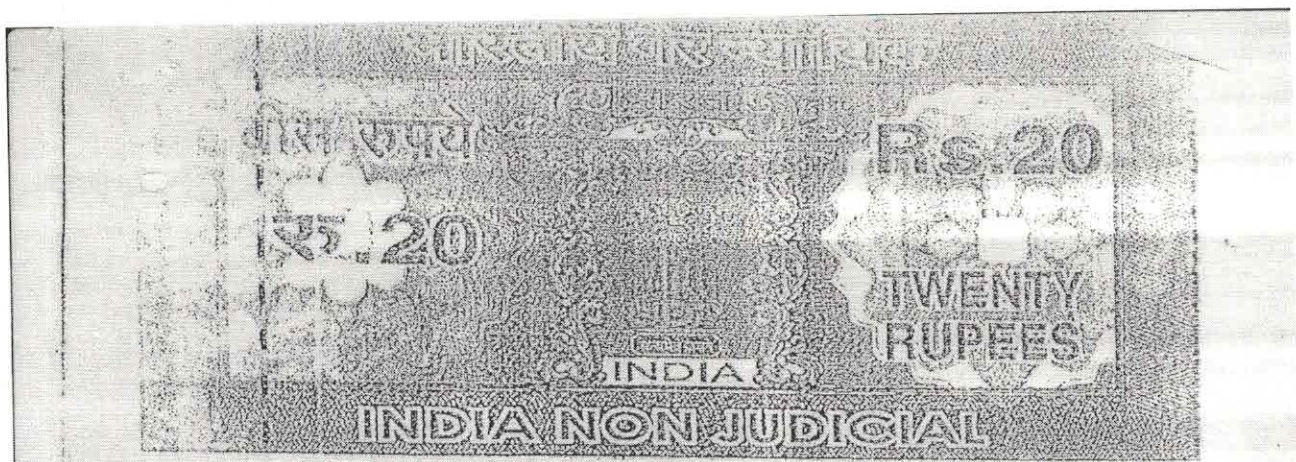

1. Name of the Association : SRI GOWTHAMA BUDDHA MINORITIES
EDUCATIONAL SOCIETY

2. Location of the office : By-Pass Road, Pydiparru,
TANUKU - 534 211.

3. MEMBERSHIP:

The membership shall be open to all who are interested in promoting the society to achieve its aims and objects. Every member shall pay an amount of Rs.25/- towards admission fee at the time of enrolment as member. The membership shall be approved by the President. After obtaining the membership the member shall abide by the Rules and regulations of the society. Gentleman of status and rank may be invited by the President to become patrons and Vice-partners by pay a sum approved by the President.

4. TERMINATION OF MEMBERSHIP:

The membership shall get terminated:

- On resignation.
- On death
- Failure to attend 3 consecutive meeting.
- By removal by the President.

5. GENERAL BODY AND ITS FUNCTIONS:

A General body consists of the members enrolled as per article 3, will meet in the month of August every year.

It is authorised:

- To elect the Managing Committee.
- To pass the budget for the ensuing year and approve the expenditure Statement of the previous year.
- To approve the report of the activities of the Society.
- To appoint an Auditor.
- To transact any other matter for the benefit of the society.

For extraordinary and special meeting the President shall on the motion of 4 members from the Managing Committee or on the requisition of 15 members General Body convene a meeting of General Body. Seven days notice shall ordinarily be given to members for the General Body Meeting. Two days meeting notice shall be given to members for extraordinary and special purposes.

MANAGING COMMITTEE:

The Managing Committee shall consist of 7 Members i.e. one President, one Secretary & Correspondent, one Treasurer and 4 committee Members. The Managing Committee elected within 5 years on the General Body. The President can expel any member from the society for violation any rules without assigning any reason therefore. Any interim vacancy in the Managing Committee shall be filled up by the President. The managing Committee shall meet at least once in two months or on the day notified by President. An annual budget shall be presented by the managing committee to the General Body at the annual General Body meeting. The President can write off all irrecoverable dues owing to the Association. The Managing Committee shall have power to frame byelaws not inconsistent with the rules for the regulation of the business of all sections of the Association subject to the approval of the General Body at its next meeting.

7. DUTIES OF THE OFFICE BEARERS:

PRESIDENT:

The President shall have the following powers and duties.

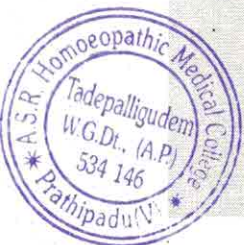
- To appoint, dismiss suspend or otherwise punish any salaried employees of the Institution and to require all or any of them furnish security.
- To accept the resignation of members.
- To supervise the punctual payments of fees etc.,
- To sanction all the contingent expenditure including those incurred by the Society.
- To arrange for the receipt, disbursement and safe custody of money and property of the society.
- To take policy decisions from time to time in order to create better educational facilities to the pupil and better amenities to staff and pupil.
- To take such suitable steps as and when necessary to augment the financial and economic positions of the Society and for the benefit of members staff and pupil.
- He shall be incharge of all the records of the society.
- He shall convene the meetings of the General Body and Managing committee.
- He shall chief executive and shall carry out all resolutions of the General Body and Managing Committee.
- He shall attend to the correspondence all transactions of the Association shall be carried out in the name of the President.

- l) He shall have power to call for and obtain from the staff of the Institution information required from time to time.

He is further authorized to open bank accounts, deposit and withdraw monies, Sign and deliver agreements, mortgage/pledge / hypothecate movable or immovable Properties with any bank/financial institutions in raising loans and do all such Acts as are needed and incidental in the running of the Societies activities.

SECRETARY & CORRESPONDENT:

She shall prepare the Agenda for the Meeting.
She shall be responsible for the General Administration of the Society.

TREASURER:

He shall receive funds of the Association. He shall maintain clear accounts and open an account with a Bank as per directions of the President. He shall prepare the budget and place the same into General Body meeting for approval. The cheques will be signed by the President.

8. QUORUM:

The quorum for General Body shall 2/3rd from the total members. The quorum for managing committee be 6.

9. FUNDS:

The funds shall be spent only for the attainment or the objects of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.

10. PROPERTIES:

The properties movable or immovable vested in the name of the Society shall be represented by the President. He is further authorized to mortgage/ pledge / hypothecate movable or properties with any bank/ financial Institution in raising loans and to all such acts as are needed and incidental in running of Societies activities. The President is further authorized to dispose of unnecessary movable and immovable properties as per the necessity.
